Once a year, National Board meets for their mid-year board meeting. As it sounds, the meeting is held halfway through the NAWIC year; the board meets to discuss issues, review the current budget and vote on any items as presented or added on to the agenda.

Most of us arrived by Thursday evening, weather permitting, and enjoyed a group dinner at a local Mexican restaurant. We haven't been together in person since Board Orientation during summer last year so there was a lot of catching up, laughter and good food.

Friday morning kicked off with an early breakfast hosted by the concurrently occurring CEC (Construction Education Consortium) where we joined up with some of NAWIC sisters there as part of NAWIC affiliate organization NEF. Morning business kicked off with a recap of the CEO Symposium attended by PE Michell and VP Hager followed by IPP Pflieger and VP Hager who shared updates on the Chapter Leadership training. Saturday business began with a NAWIC Affiliate Summit. We were joined by reps from NEF and NFSF and discussed ways to partner more with both as well as ways we can support each other moving forward. Of note, there was discussion about a joint partnership between all three organizations to offer an NEF certification course at Annual Conference with scholarship support from NFSF. Next up we met with our overseas affiliates in our Global Partners summit. We got the chance to meet virtually with women from SAWIC (South African Women in Construction), CAWIC (Canadian Women in Construction) as well as women leading women's construction initiatives in New Zealand and Australia. This was truly the highlight of the weekend and I look forward to working with these incredible women on joint efforts for our Region and all WIC.
